On April 20, 2007, in the case of Markets Edge Management v. CCA Industries, Inc., David Edell, Dunnan Edell, Ira W. Berman, Jack Polak, Stanley Kreitman, Robert Lage, Gio Batta Gori and Dubilier & Company, Inc. in the Supreme Court of New Jersey, Bergen County, Chancery Division, was dismissed to all defendants. 




